



## Golf Cart [and/or](#) SXS Form 2026

1. All powered Golf Carts and/or SXS in use on Riverside Speedway property must be registered. Registration will be proven through a Golf Cart and/or SXS Permit which must be affixed to the approved Golf Cart and/or SXS on the front driver's side in the lower corner of the windshield or front hood. **Permits are not guaranteed, they are at track discretion.**
2. The use of powered Golf Carts and/or SXS at Riverside Speedway is restricted to business use only.
3. Powered Golf Carts and/or SXS will be driven in a safe, slow, and careful manner at all times while on Riverside property. Drivers will yield to pedestrians and track vehicles. Anyone observed driving in a careless or unsafe manner will be removed from the property and have their permit revoked.
4. Powered Golf Carts and/or SXS must be driven by a licensed driver over the age of eighteen (16). **The amount of passengers must be in accordance with Golf Carts and/or SXS manufacturer.**
5. Alcoholic beverages are not permitted in any powered Golf Cart and/or SXS except for delivery purposes only. No alcohol is to be consumed by any driver or passenger while the powered Golf Cart and/or SXS is in use, and no driver shall operate any powered Golf Cart and/or SXS while under the influence of alcohol.
6. Any powered Golf Cart and/or SXS use after daylight hours must be equipped with driving lights.
7. I agree to hold harmless and defend Riverside Speedway, Inc., its subsidiaries and affiliates, and their respective members, shareholders, officers, directors, agents, employees, related or affiliated companies, sponsors, trustees, receivers, successors and assigns, are named as additional insured from any and all liability or damages including reasonable attorney fees arising from injuries to person(s) or damage to property which may arise from the use of these vehicles. I acknowledge that Riverside Speedway Inc, its subsidiaries and affiliates, and their respective members, shareholders, officers, directors, agents, employees, related or affiliated companies, sponsors, trustees, receivers, successors and assigns, do not accept any responsibility or liability by virtue of registering powered Golf Carts and/or SXS.

Failure to comply with these terms may result in revocation of the Golf Cart and/or SXS Permit, the Golf Cart and/or SXS being impounded and/or forfeiture of Golf Cart and/or SXS privileges. My signature on this form signifies full and total acceptance of these terms and agreement to comply.
